ORDER

42. MA 2513/2019, MA 2514/2019, MA 1661/2019, MA 1662/2019 IN CP.(IB)-3558(MB)/2018

MA 2514/2019 has been filed by the Resolution Professional under section 12 (2) of the IB, Code 2016, seeking an extension for further 90 days beyond 31.7.2019 for completion of CIRP.

The applicant contends that during the 5thCoC meeting held on 8.7.2019, the members were updated on the Resolution Process of the Corporate Debtor.

The CoC was informed about the requests received from the Prospective Resolution Applicant for extension of the timeline. Given the request received from the Prospective Resolution Applicant the CoC after discussion and consideration, extended the last date for submission of the Resolution Plan of the Corporate Debtor on 20.7.2019 by 99.94% voting shares of the CoC.

Based on the request from prospective Resolution Applicants for seeking an extension of 90 days, for submission of resolution plan till 20.7.2019, the CoC discussed and deliberated. The CoC considered that once the resolutions plans are submitted, additional time would be required for review of the resolution plans for compliance with the provisions of the Code; conducting 29 A Checks on the Resolutions Applicant; negotiation process and subsequent consideration and approval by the CoC, the CIRP may not get completed within the 180 days' timeline and an extension of 90 days would be required to effectively bring the resolution process to a conclusion. Therefore the Resolution proposal was put to e-voting from 10.7.2019 to 12.7.2019. The CoC by a voting share of 99.93 %, approved the Resolution for seeking an extension of another 90 days beyond 31.7.2019, for completion of the CIRP of the Corporate Debtor.

The CoC further authorised the applicant to apply for seeking an extension of 90 days for completion of CIRP. The copy of the minutes along with attendance sheet is annexed with the application, which shows that the CoC with vote shares 99.9411% has been approved for seeking an extension of further 90 days w.e.f. 31.7.2019.

Based on the unanimous resolution of the CoC, the application deserves to be allowed.

Misc Application filed for seeking an extension of further 90 days for completion of CIRP is allowed

MA 2514/2019 is disposed of accordingly.
